[Point benefit for service usage and payment]

- * 1: Requirements must be met at the cut-off point at the end of each month. You may not be eligible for the redemption going forward, for example, if you cancel your line before Ponta points are redeemed.
 - * 2: You must be an au PAY Card member (enrolled) at the cut-off point at the end of each month. If a new card is issued around the end of the month, benefits may apply from the following month.
 - * 3: At the cut-off point at the end of each month, you must have completed the opening of an au Jibun Bank account. In addition, if your au Jibun Bank account has been canceled, you will no longer be eligible for the benefit.
The date the account is considered open is the date that au Jibun Bank's identity verification is completed, and it may differ from the date the ATM card arrives.
 - * 4: At the cut-off point at the end of each month, you must have completed the registration of your au ID on the au Jibun Bank website.
 - * 5: Until February 2025, a preparation period is provided for setting the debit account of the au PAY Card to au Jibun Bank. Even if the account is set to a bank other than au Jibun Bank, the benefits will apply as long as you hold an account with au Jibun Bank.

[au PAY Card payment benefit]

- ※Sales slips (sales information) that have arrived at au Financial Service Corporation during the current month (calculated based on the date of receipt of the sales) are applicable. ※If a family card member is subscribed to au Money Activity Plan+, the benefits for their usage will be returned to the family member. ※Some merchants and specific transactions (au/UQ mobile/povo fees, au Simple Payment Service (integrated payment of communications fees), au/UQ electricity, au Kabucom Securities investment trust installments, au PAY Gold Card annual fees, new ETC card issuance or reissuance fees, top-ups to au PAY balance, etc.) are excluded from this benefit. Customers with an au ID for personal use (au IDs used for corporate contracts cannot be used when applying for this service)

[au Jibun Bank]

- ※KDDI Corporation will act as an intermediary for concluding contracts for acceptance of Japanese Yen and foreign currency deposits and fund lending as a bank agency with au Jibun Bank Corporation as its affiliated bank.
- ※au Jibun Bank services are not available at au Style/au Shop locations and stores offering au products.

[Requirements for opening an au Jibun Bank account]

- ※Customers residing in Japan (residents in accordance with the Foreign Exchange and Foreign Trade Act (Foreign Exchange Act))
- ※Only one account may be opened per person.
- ※For details on requirements for opening an account, visit the au Jibun Bank website.

[Common points of note regarding service payment benefits]

- ※If you change the type of your au PAY card before the cut-off point (end of each month), the redemption rate of the new card type will be applied to the amount spent using au PAY (code payment/online payment) and au PAY Card shopping transactions made before the change.
However, if the type of au PAY Card is changed around the end of the month, the redemption rate for the new card type may be applied from the following month.
- ※If a new au PAY card is issued around the end of the month, it may be applied from the following month.
- ※The redemption of Ponta points may be split or delayed for various reasons.
- ※If this plan is applied in the middle of the month, payments on and after the date of application will be applicable. However, for the time being, the first payment of the month will be covered.
